## 9.1.1. REQUEST FOR ELEMENTARY EXTENDED FIELD LEARNING EXPERIENCE – 6TH GRADE CAMP

Listed for the Board's information is the Superintendent's approval for the following extended field learning experience as presented on the attachment.

Participating staff at each elementary school in the district are planning to take students to the San Bernardino Mountains to participate in an outdoor science school experience during the 2022-2023 school year. Each school will participate in fundraising events in order to finance these field trips. Students from each school will travel by district bus and/or private transportation. There will be a sufficient number of chaperones provided. All requirements of board policy and administrative procedures concerning extended field learning experiences will be met.

## 9.1.2. REQUEST FOR SECONDARY EXTENDED FIELD LEARNING EXPERIENCE

Listed for the Board's information is the Superintendent's approval for the following extended field learning experience.

Mayfair Middle / High school students and participating district wide GATE students to travel to Catalina Island Marine Institute for an Extended Educational Learning Experience - March 31 - April 2, 2023.

The Mayfair High School GATE Program, under the direction of Darrel Nashimoto, has requested permission to travel to Catalina Island to attend the Marine Institute (CIMI). To participate in an extended educational learning experience from March 31 through April 2, 2023. This trip is the accumulation of an after school enrichment Oceanography/Marine Biology program. This is an optional district wide GATE program that allows schools to participate in a Marine Biology/Oceanography program. The program starts with an after school program that meets once a week for three weeks

before the CIMI trip with a follow up meeting for debriefing. Once there students will study marine fish, snorkel, hike and participate in other enrichment activities for the students. They will be chaperoned by one administrator, two certificated staff members, and 4 parents. The students will miss one day of school and will be responsible for all assignments missed due to the extended field learning experience. The trip will cost approximately \$325 per student including transportation, lodging and all activities. Funding will be provided through parent contributions. The students will be traveling by boat. Student transportation to and from the venue is the responsibility of the parent. All requirements of board policy and administrative procedures concerning extended field learning experiences will be met.
