# 8.1. THEORY OF ACTION

Superintendent Dr. Ben Drati will facilitate a study session on the Theory of Action which he will lead the District through. In the study session, Dr. Drati will delve into a high level description of a framework that will be used in the District to achieve the student engagement and achievement results we aspire for in the Bellflower Unified School District. Dr. Drati will first discuss how a well-established framework for leading continuous improvement fosters a culture of focus, coherence, mutual accountability, and effective collaboration.

Secondly, Dr. Drati will also discuss how teaching cross-cultural and socioemotional skills through a project based inquiry approach will help students to:

- Increase self and others' expectations for additional learning and achievement by providing a process
- Increase student engagement in learning through personalization and ownership
- Connect students to the "real world," which is often more reflective of their own reality and cultural identity, which can be particularly important for students from other cultures

- Resonate with spiritual values that link to vast numbers of the population, whether secular or religious
- Build skills, knowledge, self-confidence, and self-efficacy through inquiry
- Build new relationships with and between the learner, their families, their communities, and their teachers
- Deepen human desire to connect with others to do good

Lastly, Dr. Drati will discuss how a major focus of the District will be to reflect on and address real or perceived barriers for student success and desired outcomes, no matter their race, religion, gender, disability, and socio-economic status.

#### 8.2. BOARD BYLAW 9005 – GOVERNANCE STANDARDS

The Board of Education believes that its primary responsibility is to act in the best interests of every student in the District. The Board also has major commitments to parents/guardians, all members of the community, employees, the State of California, laws pertaining to public education, and established policies of the District. To maximize Board effectiveness and public confidence in District governance, Board members are expected to govern responsibly and hold themselves to the highest standards of ethical conduct.

The BUSD Bylaw 9005 is drafted and designed to provide clear guidance as Board members act in the best interest of the students and communities of BUSD. The Board will review the previous and existing bylaw and some proposed new language to add. At the end of the discussion, staff will seek guidance on the language to bring back for approval at the next board meeting.
